HCP is the general partner of HCPF. Mr. Manko is the managing member of both HCM and HCP. HCPF owns directly 2,925,456 shares of common stock and pursuant to a Warrant issued August 11, 2014 a right to immediately acquire 976,450\* (subject to adjustment as set forth in the Warrant) shares of common stock at an exercise price of \$0.45 (subject to adjustment as set forth in the Warrant) per share. By reason of the provisions of Rule 13d-3 of the Act, each of the Reporting Persons may be deemed to beneficially own 3,901,906\* shares of the Issuer's common stock. Each of the Reporting Persons disclaims beneficial ownership of any of the securities covered by this statement.

\* Excluded from the Reporting Persons' beneficial ownership are 23,550 additional shares of common stock issuable upon exercise of the August 11, 2014 Warrant beneficially owned by the Reporting Persons due to a conversion cap that precludes the holder thereof from exercising these Warrants to the extent that the holder would, after such exercise, beneficially own (as determined in accordance with Section 13(d) of the Securities Exchange Act of 1934, as amended) in excess of 9.99% of the shares of common stock outstanding.
